

## **2018 Illinois FFA Leadership Camp Participation Agreement**

Camper & Parent/Guardian - Please read the following agreement, and then print the Camp Signature Form that is located in the File Tab on the Caboodle Website in your child's health profile, and follow the instructions on that form. Once the form is signed and the form has been saved to the computer, please upload it to the Caboodle "Cart" Section in checkout. Please make sure the form is readable before uploading the form.

### **General Behavior Expectations**

While participating in Illinois FFA Leadership Camp, which is managed by Illinois Association FFA there, are certain behavioral expectations that must be observed by all participants to maintain good standing with FFA and participation in these programs.

All participants in an event or activity sponsored by FFA are prohibited from involvement in unsafe, irresponsible, and/or illegal conduct. You are prohibited from consuming alcoholic beverages. In addition, you must abide by all rules and regulations established by FFA for participation in leadership camp.

1. I promise that my attitude, conduct and appearance will be such to reflect credit on my chapter, school, community, and state FFA association.
2. I promise to abide by the National FFA Code of Ethics.
3. I will not be in a cabin of another participant of the opposite sex. Failure to abide by this rule will result in immediate dismissal from the camp and my parent(s)/guardian(s) will be notified.
4. I will not use drugs, alcohol, or tobacco at any time during the camp. I understand if I violate this rule, I will be sent home immediately at my own expense and my parent(s)/guardian(s) will be notified.

### **Personal Conduct Agreement**

In exchange for my being allowed to participate in leadership camp sponsored by the Illinois Association FFA, I, and my parent(s) or legal guardian(s) (individually and collectively referred to below in the first person singular) agree to be bound by the behavioral expectations set forth above and each of the following.

1. I agree to participate in Illinois Association FFA's leadership camp according to the guidelines set forth in this Personal Conduct Agreement and other applicable FFA publications.
2. I understand that Illinois Association FFA reserves the right and I agree that Illinois Association FFA has the right to immediately terminate my participation in the camp at the sole discretion of Illinois Association FFA, through its representatives, if I (a) engage in behavior that is unsafe, irresponsible, illegal, or otherwise contrary to FFA policy as expressed above or (b) consume alcohol.
3. I further understand and agree that if my participation in leadership camp is terminated pursuant to the preceding paragraph, (a) I will be solely responsible for all costs associated with my early termination, including my travel expenses, and (b) I will not be entitled to any refund of money I have paid to FFA for my participation in the camp.
4. I agree to allow FFA and its representatives to make reasonable, unannounced searches of my living quarters and personal belongings if FFA reasonably suspects that I am violating the behavioral expectations set forth in this Agreement and other applicable FFA publications.

### **Video/Photo/Audio Consent**

I, the undersigned, do hereby consent to the use by the Illinois Association FFA of my image, voice, or both described below, in (1) the video, photograph, or audio recording described below; and (2) any video, photograph, or audio recording reproduced either in whole or in part from the video, photograph or audio recording described below: regardless of whether these materials are used for fundraising, advertising, publicity, or any other purpose on behalf of either the Association or its Foundation.

- I warrant that I have the full right and authority to grant this consent.
- In addition, I waive all claims to compensation or damages based on the use of my image or voice, or both, by either the university or the Foundation. I also waive any right to inspect or approve the finished photograph or video or audio recording.
- I understand that this consent is perpetual, that I may not revoke it, and that it is binding on my, my heirs and assigns.
- I further attest that I have read this consent form and fully understand its contents.
